We were able to assess the tasks necessary for the functioning of the dispositifs of the Guarantee of our international School: their challenges, their complexities.

During the review with our colleagues, we also appreciated the value of the new dispositifs put in place by the **College of Animation and Orientation of the School**: The CAO's Cartels of the School; the Afternoon of the Cartels; *Feuilles Volantes*, which publishes the work of these cartels.

We will continue the publication of the Bulletin Echos, Echoes, Ecos, Echi, in its new format, of which this is Number 5, in order to give regular news of the ICG's work, which concerns/interests all the members of the School engaged in the EPFCL. All the dispositifs have to do with the extension of psychoanalysis in accordance with its intension, so singular and proper to each psychoanalysis.

At the start of our experience, we are retaining all the measures put in place by our predecessors; we are thus publishing the Internal Rules of the ICG (attached) as we received them, and we will modify them as needed during the course of our mandate. We present it to you today, with changes in the names of those occupying the functions at the local and international levels. Among the good ideas of our predecessors, we are keeping the presentation of members of the ICG 2023-2024, so that everyone can identify them.

✚ **Setting up the dispositif of the Pass**

Organizing cartels of the Pass for the 4 passes completed since the end of 2002 required a lot of discussion and exchange, during which we could grasp how the supposedly « practical » questions related to the dispositif depend on conceptions each has of psychoanalysis and the « passage » to the analyst.

✚ **Cartels of the pass**

We have kept the prior arrangements: these cartels are composed from within the ICG, case by case, according to finished passes to be studied, with colleagues from the three dispositifs of the School (2 for the Americas, 2 for France, 1 for Spain) and taking into account the linguistic compatibilities and analytic incompatibilities.

Four passes finished since this ICG took office. The two cartels composed to receive the testimony will meet in Sao Paulo (Brazil) the 29-30 of April 2023.

✚ Two points under debate about the current functioning of the dispositif of the Pass:

In the process of preparing the cartels of the Pass, we encountered two questions that require work. Briefly:

- **The current use of virtual platforms as an alternative to being in person.**
- **The issue of transferential incompatibilities**

✚ Passes “in person” or by Zoom if necessary.

After the pandemic, new uses of technology became established. The communication benefits, both monetary and geographical, are clear. So then, specifically in terms of listening to the passes, is it suitable to take advantage of the possibilities offered by virtual platforms? Or is presence a condition for the best possible functioning of the dispositif of the Pass? Can one of these modalities in itself be defined as more in line with the analytical discourse, or will our preference ultimately depend on other variables? Eventually, we will make a more precise evaluation once the necessary time has elapsed for the experience that is in progress.


✚ Clarification of the transferential incompatibilities in the constitution of the cartels

Regarding incompatibilities, the point of discussion was about the proximity of relations between a member of a cartel

of the Pass and the passants and passeurs. Does the principle of incompatibility apply just because they share a cartel space? Explicit reference in the Internal Rules of the ICG, albeit by way of example.

As we are a community of analysts, transferences (plural) are widespread, not only in the analytic dispositif, and cannot be avoided. We see that they are widely present among the members of the ICG and other participants, such as passeurs and passants.

This is why it is important for us to examine the Internal Rules and eventually make modifications to reduce possible ambiguities.

 **Our discussions have led us to make the following modification to the Internal Rules:**

Previously, paragraph 2.2 “Stages in the Functioning of the *Dispositif*” read as follows:

« The secretariat of the ICG, together with members of the ICG, decides on the composition of the cartels for the various passes, taking into account the languages and incompatibilities. It is appropriate to avoid the presence in the cartel of: the analyst of a passant, the analyst of a passeur, a passant’s current supervisor, possibly a current analysand of this analyst, as well as persons who are too close, for example on account of participation in a cartel ».

After our March 26th meeting, with everyone participating in the discussion and a vote on this modification,

we propose the following change to the last phrase in *Stages in the Functioning of the Dispositif*:

«The secretariat of the ICG, together with members of the ICG, decides on the composition of the cartels for the various passes, taking into account the languages and incompatibilities. It is appropriate to avoid the presence in the cartel of: the analyst of a passant, the analyst of a passeur, a passant's current supervisor, possibly a current analysand of this analyst, as well as persons who are too close. Given the multitude of encounters and various working links among the colleagues of our School, it is up to each one to assess his/her links to the passants and passeurs and to take a decision regarding a possible incompatibility. »

You will find attached the complete text of the Internal Rules of the ICG 2023-2024.

Epistemic sharing

How does the ICG propose to question (itself)?

The previous ICG met every month with a theme and individual productions around this theme. Permanent work cartels were constituted to report on specific issues or about the work of the cartels.

The ICG currently wishes to experiment with a collective work among all 17 colleagues. This shared work could become the foundation for links and shared reflection. The experience can be evaluated to assess whether work continues under this format or in “epistemic” cartels.

✚ ***What should the psychoanalyst know?*** This is our initial question.

The ICG therefore began with two interventions, one from Didier Castanet and one from Ricardo Rojas, about the knowledge of the psychoanalyst, summarized below.

✚ **Ricardo Rojas:** « *The framework of knowledge is not the setting but what is missing* ».

After the pandemic, one returns to habits without questioning the benefits of the experiences established in the face of confinement that mobilized us from our usual customs. What made the absence of certain habits present? Did it make us think about the consequences of those absences in the light of analytical discourse? Did it make us think about the nature and scope of notions such as body, presence or others? And when what had been missing returned, beyond effusively welcoming reunions, in my opinion, we should ask ourselves if some standards have been established that have nothing to do with what it is authentic in the pass. What conception do we have of the Pass and what are we waiting for? Lacan affirms at Sainte-Anne on November 4, 1971 “...that, in psychoanalysis, there is such a thing as fundamental and primary knowledge”. The issue is to know what knowledge we are taking about, given there are various forms of knowledge in each established or labile discourse. It would be important to continue reflecting on various points susceptible to slipping

into a setting of the pass, mutatis mutandis “ritual forms of technique” at the center of post-Freudian treatments that, as Lacan said in 1956 in “Situation” “are valued to the point of degradation of the objectives.”

✚ **Didier Castanet:** « *What should the psychoanalyst know? ...* ».

It will be a matter of considering the relationships between the psychoanalyst and knowledge and, more particularly, what the analyst has of knowledge, that is, the status of this knowledge. Thus, the beginning of my title, the beginning only: « What the analyst has of knowledge ».

For this we refer to two passages from Lacan. One about Nicolas de Cusa’s « learned ignorance » and one about Georges Bataille’s « non-knowledge ».

As in « learned ignorance », in my title between knowledge and non-knowledge, we can perhaps find an oxymoron.

Nicolas of Cusa and learned ignorance, Georges Bataille and « non-knowledge ».

In returning to Lacan’s reference to Nicolas of Cusa’s « learned ignorance » we will examine the passage from conduct of the treatment to « non-knowledge » at issue at the end of analysis.

The reference to « inner experience » and to George Bataille’s « non-knowledge » will allow me to consider the question of non-sense, the impossible, thus the real. Indeed, non-knowledge in Bataille is not only what appears from knowledge, in its horizon, but also where knowledge is

dissolved, goes beyond its limits: a moment when we can no longer properly speak of an inside or an outside, a moment without horizon. The system of non-knowledge has the status of impossible, it wants to grasp it, attain with words what must escape discursivity. It is a senseless subversion of sense, the mortgaging of intelligibility, a « revolt that contests all possibility and a holding on only to the impossible», as Bataille tells us.

In returning to the first lesson of the seminar «The knowledge of the psychoanalyst », we could say that Lacan took up this concept of learned ignorance in order to make it an ethical principle for psychoanalysts. It is primarily to the doctor that he addresses himself, therefore to medical science.

The Pass is an experience of knowledge. The procedure of the Pass has as its goal to evaluate the radical modification of the analyzed subject. He is the one who knows what he is in his desire. Also, we see that this final evaluation of the analytic experience bears on the being of the subject and that it is correlated to a knowledge.

The College of Animation and Orientation of the School (CAOS)

The College of Animation and Orientation of the School supports the epistemic dimension of the international School. The « Principles for a School » specify that « *this College has the mission of animating the debate of the School at an international level. This College is in charge of coordinating the activities and/or themes of the Seminars of the School; initiate them there where they*

don't exist, plan Journées, in short, it will make the work of the School exist at the international level».

For this « mission » of animation the CAOÉ may count on the local dispositifs of the School, or if needed on the delegates of Forums belonging to the School.

It is responsible for publishing and circulating its electronic journal WUNSCH and, since their creation, it supports the dynamics and aims of the Intercontinental and Bilingual Cartels.

The members of the ICG concur with Marc Strauss's beautiful homage to Patrick Valas, and with those by all of our colleagues of the School and the IF.

Many of us benefited from what he made available to us on his site, where he wrote: : « open to anyone » and where he wished to put knowledge « within the reach of whoever comes here to acquire it». He never failed to respond to a request, sent the desired references, shared his knowledge and his passion for psychoanalysis, without limits.

On 9 March, **Patrick Valas**, our friend and colleague, passed away.

Stricken by illness, he had been out of sight for some time but there was always someone to ask about him. It is true that his presence colored the atmosphere: was he going to rage against our analytical pusillanimity, recall a decisive historical or theoretical point, suggest a new idea or.... say nothing? We knew that his will-o'-the-wisp interventions - as he called them himself, with all the tragedy and lightness that the expression word entails - would awaken us. In short, we all loved Patrick and Patrick knew everyone, all of "our world", from the time of the Freudian School of Paris. After its dissolution, curious about the current events of the groups, associations and

schools, he chose to join us at the Forum, for our pleasure and our honor.

Patrick is also an Internet site, an inexhaustible monument of references, documents, recordings made available to all; he is books, a seminar pursued over the years, analysands for whom he spared no attention, a friend with whom we could have a drink in Montparnasse after work.

Sure, that the will-o'-the-wisp is not ready to die out in our memories, we share the sadness of those who knew him and present our most sincere condolences to his family and friends

To Valas with affection

In Caracas Lacan admitted that those who listened to him read him. It is an important acknowledgement insofar as, at that time, he distinguished between those whom he had directly formed and those who did not have his voice but only his written words. That being said, for myself, I thank those who orally received Lacan's teaching, for the written transcriptions of his seminars, and for the initiative of Patrick Valas, who published on the site which bears his name texts not available on Staferla and to which we had no access otherwise.

In Brazil, due to the initiative of the Forum of the Lacanian Field of São Paulo, we have translated two seminars

which had not been translated into the Portuguese language. For us, it is essential that those who do not read French are able to have access to seminars translated into Portuguese. Translating is a subversive act that extends Valas's subversion in making available words spoken and written by Lacan, and in this way making possible a transmission of the precision that Lacan taught.

In his tribute, Marc Strauss says that Valas called his interventions will-o'-the-wisp. I cannot fail to recall that, here in Brazil, our native peoples called the will-o'-the-wisp the Boitatá (Mboitata). Something that suddenly appears, like a fire serpent, to protect the forests; so as to not be affected by it, they recommended keeping still with one's eyes firmly closed. This legend finds its echoes in many other cultures, France, Germany, the United States; Portugal has created stories to try to name this fire that frightens and burns.

Dear Patrick Valas, this fire that emanates from an underground gas is truly a good name by which to remember you. You leave us a legacy that, in spite of innumerable attempts to bury it, Boitatas, continues to break free and maintain the light of our formation, the heat and enthusiasm of the teaching of psychoanalysis. How can we not say « thank you Valas » each time we read a seminar, a text, or listen to an audio of Lacan, that you made available? « Thank you, Valas » for your seminars, your diverse bibliographies, and for the click your site offers us! Thank you Valas.

We have the pleasure to present to you the College of Animation and Orientation of the School, the CAOÉ 2023-2024.

This College of 4 persons chose a « support team » which will help in diffusing projects related to the animation and orientation of the School, for all members of the School, in particular in Zones of the IF where there is not yet a local Dispositif of the Guarantee.

The initiative of International and Bilingual Cartels of the School, launched in 2021 by our predecessors, has turned out to be a wonderful idea and we cannot but do everything in our power to follow through with it!

The catalog of cartels published in ECHOS N° 4 from November 2022 shows us a network of 25 cartels gathered around original themes, but all relate to the question of the intension of psychoanalysis which orients its extension.

We began by approaching the 25 Plus-One's of the cartels to share current questions posed by the experience, and most of the 20 people who responded to our questions expressed their gratitude for, above all, the invention of this dispositif and their enthusiasm for the experience in progress.

Despite the foreseeable difficulties encountered and expressed by some —differences in languages, cultures, time zones, calendars—the encounters and the shared elaboration of work allowed a new understanding of the international dimension of the School.

Some of the more than 120 members of the School who engaged in this work connection and “praxis of theory” were able to present the products of their research during two afternoons of the Cartels of the School, organized in 2022, or in the two issues of the a-periodic publication: “Feuilles Volantes”.

We hope the experience will rebound and that other cartels will enlarge the reach of this network.

1-Feuilles Volantes N°3 will appear in September and will publish the productions of some Cartels in the process of finishing their journey.

2- A mid-September afternoon of the Cartels of the School will also allow us to learn more about each other's work.

We will soon communicate the themes and dates of these two events.

3- And so, LONG LIVE THE CARTELS OF THE SCHOOL!

1.4. THE WORK OF THE ICG

1. **The cartels of the Pass.** They decide on the passes and are composed from within the ICG case by case, in accordance with finished passes to be studied and based on linguistic competencies and analytic incompatibilities.

2. As they already do regarding the passes after the cartels of the Pass have spoken, the 17 members of the ICG meet periodically to consider the crucial problems of psychoanalysis in intension, above all those that arise in the passes that have been heard. This new arrangement aims for better exchange. They shall provide an account of their debates and, at the end of their term, evaluate this new formula of work.

2 –FUNCTIONING OF THE DISPOSITIF OF THE PASS

2.1. THE LIST OF PASSEURS

This is established in each dispositif by the local secretariats of the Pass (See below § 2.2.), based on proposals by AME's of the dispositif or of another, if the passeur lives there, speaks the language and has his principal practice there. The local secretariats transmit the list to the ICG which holds it for the entire set of dispositifs along with all information from the files of passeurs that the secretariat sends to the ICG at the beginning of their term.

2. 2. STAGES IN THE FUNCTIONING OF THE DISPOSITIF

Requests for the Pass are received locally by the secretariats of the Pass who also establish the list of passeurs. This list is revised and regularly updated by these same

secretariats. The candidate is received by a member of the local secretariat of the Pass, who notifies the candidate's secretariat which either approves or declines the request. In the latter case and if necessary, a second interview may be scheduled. The secretariat sends the candidate his secretariat's answer and potentially has him choose at random his passeurs. He also tells the passant that he must inform either him or the secretary when the testimony has finished. A passant may, at his discretion, reject a passeur and choose another name.

The secretaries of the Pass continuously transmit to the secretaries of the ICG:

- the list of requests for the Pass
- the list of passes that have actually proceeded following the candidate's interview(s) with one or more members of the secretariat, along with the names of the two passeurs, and the passant's file received from the secretariat, including all the information necessary for the composition of a cartel of the Pass.

The secretariat of the ICG, together with members of the ICG, decides on the composition of cartels for the various passes, taking into account the languages and the incompatibilities. It is appropriate to avoid the presence in the cartel of: the analyst of a passant, the analyst of a passeur, a passant's current supervisor, possibly a current analysand of this analyst, as well as persons who are too close. Given the multitude of encounters and various working links among the colleagues of our School, it is up to each one to assess his/her links to the passants and passeurs and to take a decision regarding a possible incompatibility. »

2.3. TRANSMISSION OF THE ANSWERS OF THE CARTELS OF THE PASS

The cartel composes their answer addressed to the passant without any need to justify it and in the simplest way. According to the case: « The cartel has nominated you AE » or « The cartel has not nominated you AE. » On this occasion, they also transmit the list of members of the cartel which was composed for this Pass. Based on this, each cartel will decide, in accordance with the particulars of the case, if they want to add something else. The answer is sent without delay.

A member of the cartel, chosen by the cartel, transmits the answer orally to the passant, if possible, in person, or by telephone when distance does not allow this. If he wishes, the passant may request another meeting with another member of the cartel.

The answer nomination or non-nomination, along with the composition of the cartel of the Pass, is communicated, to be archived, to the secretariat of the ICG and to the secretariat of the Pass of the dispositif concerned.

The secretariat of the ICG (composed of the two secretaries of the ICG) ensures that a record is kept at all stages. The paper version of this Record of passes is transmitted from one ICG to the next.

2.4. THE PASSEURS

The AME's of the EPFCL may designate passeurs as the text of the « Principles » outlines. They do this at a moment they consider opportune, through the local secretariat of the Pass in their local dispositif of the School (LDS) or another, where the passeur lives, speaks the language and exercises his main activity.

The secretariats of the Pass randomly choose passeurs for the passants from a list of passeurs. This list is composed taking into account the incompatibilities—linked to the possible risks of transferential bias—such as passeurs who have the same analyst, a passeur in supervision or in analysis with the analyst of the passant, a passeur in a cartel with the passant or with the analyst or supervisor of the passant. It is also imperative to give preference to passeurs not yet in an ongoing pass who do not yet have a Pass in progress or, failing this, have fewer ongoing passes. The passeurs must necessarily speak the same language as the passant, or a language that the passant speaks, but they need not be from the passant's country. If a dispositif lacks passeurs who speak the language of a candidate for the pass, the secretariat may contact the ICG which holds the notebook of passes, in order for the ICG to indicate other dispositifs that have passeurs who speak this language.

The passeur's term is limited to two years or three passes. If two years after his designation a passeur has not been chosen, the AME who designated him may renew his designation if necessary for the functioning of the local dispositif due to a lack of passeurs.

The secretariats of the Pass must ensure that the passant who has chosen his passeurs is ready to begin his testimony without delay, and they see to it that the testimony is not prolonged indefinitely.

2.5. THE INTERNATIONAL COMMISSION FOR THE ACCREDITATION OF THE AME's

Composition of the Commission

The second year of its term, the ICG composes from within itself the International Commission for the Accreditation of the AME's. Its composition observes a certain proportionality with respect to the number of members of the School in each zone. The list of new AME's is published in June/July of this second year.

Functioning

At the beginning of its work, the ICG reminds the local commissions of the tasks incumbent upon them regarding the criteria and gathering of information about possible AME's, especially for Forums attached to a dispositif. Within a timeline established by ICG, the local Commissions for the Guarantee transmit the proposals for AME that they consider should be examined by the International Commission for Accreditation (ICA).

3 – ADDENDUM: ADMISSION OF MEMBERS OF THE SCHOOL

A) The distinction between admission to a Forum and to the School

The rule about first entering a Forum, then the School, seems worthwhile to maintain. Nevertheless, it should be applied sensibly and, in exceptional cases, a simultaneous admission to a Forum and to the School could be envisioned.

B) The question of criteria has been revisited and has led to the following suggestions:

Two interviews or one interview with two persons from the Commission does not seem excessive. Regular participation in the activities of a Forum or of a pole, especially in cartels, and possibly in the Clinical College to which the candidate

belongs, are taken into consideration. But wider participation in national activities, for example the Journées, must also be taken into account.

Insofar as our School has international dispositifs, the international dimension cannot be ignored. This international dimension must be presented from the very first interview, so that the candidate be aware of it before the second interview. Papers published following Journées, inter-cartels, etc. are an objective factor of the candidate's implication to be taken into account. Consultation with the analyst or supervisor cannot be something obligatory. It is up to the Commission to decide if and in which cases, this could be opportune.

C) Condition for admission as Member of the School for members of Forums attached to the dispositif-France: the general condition for admitting a member of the School belonging to an attached dispositif is sufficient knowledge about his analytic formation. On this basis, the CAG gives responses which are of course suited to each case. On the other hand, if a candidate has done the Pass and has not been nominated AE, the cartel which heard his testimony may possibly propose his admission as Member of the School.

These cartels will be **intercontinental and bilingual**. This is their definition. They will therefore bring together **members of the School** from two different continents who speak at least two different languages. Their aim is to promote, as we have said, **new and multiple links for the work of psychoanalysis in intension** not only at the level of international and national bodies where it already exists, but at the very base of the School by engaging all Members of the School who have not yet participated at the level of the bodies of management. They will find in this network a space where their work can find a **new resonance**, possibly via a newsletter, Study Days, intercartels, and other forms to be invented etc.

As a result, we also hope to gain more clarity in **the distinction between the work of the Forum and the work of the School** – a distinction which is constitutive at our origin and which also corresponds to two different modes of admission, each with its own criteria which have not ceased being debated since the beginnings of the School. They deserve to remain in the spotlight with the passage of time.

In addition, as we have said, for the work to be possible, in each cartel only one language will be spoken and that supposes, specifically, that the members of the cartel have in common one of the five languages of our community, those in

which we send you this message. These cartels will therefore be bilingual in their composition, their members speaking at least two different languages as has already been said, but one of these two languages will not necessarily be the one spoken in the cartel: depending on the case, the work can be done in any one of our five languages, English, Spanish, French, Italian or Portuguese.
